Generally

For your visit to the Posidi Studios website providing your personal data is not required. We will obtain it only if you provide us with it after submitting the electronic contact form.

The processing of personal data of the users of the website is governed by the following terms, the relevant provisions of the current legislation on personal data regarding the protection of the individual from the protection of personal data, instructions and regulations of the Personal Data Protection Authority.

Collection of Personal Data and the purpose of their processing

According to EU General Regulation 2016/679 (Article 4 No. 1), personal data is any information relating to an identified or identifiable natural person. Such examples are: the name, the address, the date of birth, the gender, the mobile phone number, the e-mail address, etc.

By contacting us, we collect from you:

- Your first and last name
- Your phone number (landline and / or mobile)
- Your e-mail address (e-mail)

We collect your above personal data in order to contact you for information about our accommodation and for possible booking at our accommodation.

Purposes and duration of keeping personal data

Posidi Studios maintains your personal data until the end of your booking at our accommodation and may continue to store it for a longer period of time if this is necessary to protect its legal interests.

Transfer of personal data to third parties

Clearly and unequivocally, we inform you that we do not disclose your personal data to third parties.

Policy about Cookies

The website of Posidi Studios www.posidistudios.gr for the collection of the information mentioned in the previous paragraph as well as for its smooth operation uses cookies, which are temporarily stored in the cookies file of the user's internet browser, until its closure. Cookies are data files that can be sent to your browser. Your browser may in this case save them to your system based on the preferences you have installed in your browser. Cookies collect information about your operating system, including your browser type, and your Internet Protocol IP address. You have the option to set the parameters in your browser so that it notifies you when you receive a cookie file, allowing you to decide whether to accept it or not. In addition, you have the option to block all cookies. Please note that in case of refusal or other way of excluding cookies, you may not be able to use all the available functions of the website. Posidi Studios uses this information to analyze the traffic of its website, to control the visits of its pages and the duration of navigation on each page, in order to improve the website and to advertise its services. Your rights

- iii. **The right to restrict the processing of data:** You have the right to request the restriction of the processing of personal data concerning you if it is deemed to exceed its purposes.
- iv. **The right to object to the processing:**
You have the right to object to the processing of personal data concerning you at any time and for reasons related to your particular situation, when it is based on Article 6 paragraph 1 element e' or f' of the EU Regulation. 2016/679.

- v. **The right to delete:** You can request the deletion of your personal data whenever you want to.
- vi. **The right to portability:** Each subject may request to send the data electronically (if kept in electronic form) to another controller.
